Finance Report:

Craig E. presents financial year end 12/31/19 & 2018 net income was \$206,022 & \$58,453 respectively.

For 2019, budgeted net income was just \$8,456 and Indy Pride delivered \$197,566 more than that.

Overall revenue for 2019 & 2018 came in at \$986,269 & \$695,224 respectively. The 2019 budget called for revenue of just \$710,495 and Indy Pride generated \$275,775 more than that.

Largest contributor: \$132,451 from ticket revenue.

Tent City: This is being removed from the Pride Festival because of space allotment. Budge Review shows it did not provide enough revenue to continue keeping. We also need to ensure we accommodate ADA accessibility. This will take the place of tent city.

Donations from Individual: This has never been a profitable area for Indy Pride. Angle M. advised that Trinity Haven plans to start contributing.

Amy Downs discussed private donations as an agenda Indy Pride should go after. Chris H. advised that Indy Pride Staff plans to seek opportunities to go further on gaining revenue.
